





Encourage and Empower Team Report 2018-2019

The Encouragement and Empowerment team works to help the churches of Little River Baptist Association continue to support one another in prayer. In 2019, our prayer-partner program finished its third year in a five-year rotation. The program encourages all churches to pray for a quarterly prayer-partner church. We are encouraged as we see the churches keeping up the good work of praying for and encouraging each other.

We have heard great things from the prayer-partner churches coming together. In 2019, the Revival Fires team began to leverage our prayer-partner model so that the partner churches would not only pray for one another, but would also get together for a quarterly combined worship service.

The National Day of Prayer is an annual day of observance held on the first Thursday of May, designated by the United States Congress, when people are asked "to turn to God in prayer and meditation." Our team helps plan this annual event which is a good time to come together and pray at the Trigg County Justice Center. Community and church leaders are enlisted to conduct the service. This year's theme was to love one another. Our five emphasis points were:

Pray for the churches in America to *Love One Another*. *John 13:35*

Pray for families, workplaces, communities and cities in America to *Love One Another*.

Trustee Report 2018-2019

The 2009 5x8 enclosed trailer that was stolen from our property has been replaced and churches are welcome to reserve for church use. The Camp Cadiz enclosed trailer has been sold along with several pieces of Disaster Relief equipment that were in poor working condition. The old Disaster Relief trailer has been filled with the Camp Cadiz trailer contents, as well as some of the Disaster Relief equipment that is still in good working order. Since the absence of a Blue Hat to head up our Disaster Relief, the trailer was no longer being used, and was agreed that it would be much better utilized by our Camp Cadiz. The trailer will also be available for any church use as well.

The front entrance doors of the Baptist Center were replaced with new glass entry doors that include panic bars for safety. We are still in the process of replacing all exterior doors, and hope to get those finished soon. The lighted front sign panels have been replaced with a fresh new look, and since the creation of our new LRBA logo, we have installed our logo on the front of the building.

LED lighting has replaced the old florescent lighting in our building, and should show substantial savings in our utility costs. We appreciate so much the work being completed by Bro. Steven Nichols, who donated his time and talents to complete this much needed task.

The associational van continues to be used, but churches have been lax in the cleaning and caring of. The Guidelines must be followed in order to continue the use of. A new driveway was installed at the back of the property to assist in making it easier to park the van and Block Party trailer under the carport system. Please help us to continue to care for and respect the van use.

The Baptist Center parking lot continues to be a continued topic of discussion, as we look for ways to financially afford the replacement of. God has blessed us with this wonderful property in which to serve the Lord. Please help us to continue His work as we strive to serve Him together.

2018-2019 WMU Report

The 2018-2019 watch word is “My dear friends, stand firm and don’t be shaken. Always keep busy working for the Lord. You know that everything you do for him is worthwhile”. WMU continues to challenge Christ followers to inform and inspire Christians to influence their world for Christ. Little River Baptist WMU has worked to meet that challenge. At Halloween safe night we handed out 1000 balloons to kids that had printed on them Jesus Loves You. Again, this year kids were excited to parade through to get their balloons and paint the town orange.

We partnered with Cadiz Baptist church’s Simple Blessings in April, for the Children’s Ministry Day. The mission project was to bring items for Simple Blessings. We shared the Gospel with the kids using the Evangecube. We also presented each one with an Evangecube to take home so they can share the Gospel with friends and family. Eight children accept Christ this year. The kids enjoyed repeating back the Gospel story. They also got to make make slime and review the meaning of becoming a Christian.

We were honored to provide the Wednesday lunch for the hard workers of Camp Cadiz in July.

For 9 years Little River Baptist WMU has helped to distribute the items for Backpack Ministry. Items that kids can open easily and eat over the weekend are placed in the back packs of kids that have been identified by teacher that come to school hungry. This continues to be an effective ministry to meet the needs of kids that would otherwise go hungry over the weekend.

Two churches in our association have started back WMU this year, Liberty Point and Wallonia. Churches with WMU are more likely to have a more actively involved laity in all areas of church missions and ministry. We challenge the churches if they do not have an active WMU contact us for more information on how to get started.



2018-2019 Executive Team Report



October 16, 2018 Meeting

The Executive Team met due to the expressed desire of some of our churches to reconsider the Annual Meeting date for 2019. Pastor Steve Hardy asked the Mission Board to reconsider having the meeting on another day other than Sunday. During that meeting, the moderator asked that it be referred to the Executive Team. The team discussed that initially it was agreed that attendance seemed to be dropping off for the Annual Meeting, and wanted to do a trial of having a Sunday evening worship service in 2017. Attendance increased for the meeting, and the team felt that it should continue to be scheduled on Sunday to especially allow bi-vocational pastors to attend and to have a worship service for all churches. The group further discussed not rushing into a decision and to continue to make it a matter of prayer, and to see the attendance numbers for the 2018 Annual Meeting. The team members feel that we should keep a sense of unity within the churches. Bruce Wynn recommended that the Annual Meeting be titled the Annual Associational Worship in the future.

Another matter to be addressed was the associational choir. Following the resignation of Bill Butler, two people have offered to fill the position. Ron Yonts, member of Ponderosa, and Emma McBride, member of Hurricane. Both have recently left their churches and are visiting others. Mrs. Emma McBride has currently been helping to continue the choir. After much discussion, a motion was made to accept Mrs. Emma McBride as interim choir director. The motion was seconded and passed unanimously.

Another matter of discussion was the resignation of Andrea Hampton as Youth Leader. Andrea has agreed to continue to lead in Camp Cadiz as she has in the past. At this time there have been no volunteers from the Youth Council. No action was taken at this time.

Lastly, Bro. Paxton Redd humbly submitted his resignation as Director of Missions. The committee was saddened by the news, and Bruce Wynn made a motion to accept the resignation, motion carried.

November 5, 2018 Meeting

Old Business: A motion was tabled from the September Mission Board Meeting to change the Annual Meeting date to from Sunday to an evening during the week. A discussion was held, and the committee felt strongly to leave on Sunday evening due to the large attendance and number of churches in attendance. The committee will recommend to the Mission Board to continue having the continued worship on Sunday, by a vote from the Mission Board at the December meeting.

New Business: The committee discussed the selection of the DOM Search Committee. They discussed the by-laws and felt that nominations needed to come from the floor. They would recommend to the Mission Board a committee of 5, with Bro. Tim Smith as ex-officio member as Moderator. A layperson, pastor, bi-vocational, female and an alternate would be a good representation. The committee was in agreement to bring to the Mission Board at the November 5th, Mission Board meeting.

Other New Business: Discussion of financial matters concerning current DOM, Paxton Redd. His last day at Little River Association would be November 15. The committee was in complete agreement to recommend to the Mission Board to continue Salary/Housing, Insurance/cell, Retirement, and Christmas gift through December 31, 2018.

February 4, 2019 Meeting

The committee met to plan the Semi-Annual Meeting to be held April 8, 7:00 p.m., at Ponderosa Baptist Church. Pastor Robby Shearon of Bethany was chosen to bring the message and to ask Pastor Don Duncan from Buffalo Lick to be the alternate.

Pastor Robby Shearon made a motion to recommend Pastor Steven Nichols of New Hope Baptist Church as Evangelism/Missions assistant team leader. The team unanimously approved the recommendation.

Pastor Tim Smith of Locust Grove submitted his written resignation to the Executive Committee and Association as Equipping assistant team leader, as of our annual meeting in October. The Executive team accepted the resignation.

Pastor Brad Chalfin of Canton Baptist Church discussed the continuation of the Land Between the Lakes Area Ministry and asked for the team's guidance on that continuation. Brother Tim Smith made a motion to continue the ministry at \$195.00. The motion was carried to recommend to the Mission Board.

Due to the absence of a Director of Missions, Shari Littlejohn, Ministry Assistant, shared with the team the need for a plan for the 2019 associational mission offering. The team spent time in discussion and asked the Evangelism/Mission team leaders to come up with a plan for the offering. Some discussion was held on possibly using future offerings to purchase a new associational van, as will be needing in the near future for churches use. The van is much used by the churches and is a vital part of the ministry.

March 19, 2019 Meeting

The team finalized the program, adding Pastor Steven Nichols of New Hope Baptist Church, to present the DOM Search team report. Also agreed to leave the offering goal as \$10,000, and to make a decision later on how the offering would be distributed. We will continue setting aside \$3,000 for mission scholarships.

Vice Moderator Brad Chalfin shared a possible mission opportunity at Hillcrest Camp. Canton Baptist is currently in the planning stages of helping to make many needed improvements at the camp to continue having youth camps there.

Moderator Tim Smith shared a possible mission opportunity for helping with the tornado damage in Paducah, KY.

Bids for the front entrance door as well as (2) back entrance doors to be replaced were discussed. The trustees recommended using West Paducah glass to replace all mentioned doors. The total cost of replacing all entries to be a total of \$3,510. The committee moved to accept the recommendation of the trustees. The (2) back entrance doors were bid with tempered glass, and the trustees will get a bid for replacing with solid doors versus glass to lower the price of the replacement.

We discussed moving the Disaster Relief trailer that resides at Liberty Point. Liberty Point has graciously allowed us to use the building but is considering utilizing the building for other purposes. The trustees will be looking into finding a place for storage. The team also discussed the fact that we no longer have an active Disaster Relief due to lack of a Blue Hat to lead. The group agreed that we need to promote finding someone willing to be trained and to head up this mission.

Team leader positions were discussed for nomination at the Semi-Annual meeting. Brother Steven Nichols will be stepping up to the Missions/Evangelism team leader role and will be presented as a nomination. The team agreed to ask Orville Herndon to serve another term as Equipping Team leader. If in agreement, will be presented as nominee at the Semi-Annual meeting. Bruce Wynn will continue to serve his 4-year term as Assistant Team leader to expire in 2020. Nominations for other leaders will have to be nominated at a later date and will revisit the term limits.

Revival Fires was postponed due to the scheduling of Evangelism Sunday as well as issues with the Sunday date. It was discussed that it was probably too late to try and reschedule for the spring. Brother Brad Chalfin mentioned that an option might be to let our partner churches worship together for Revival Fires, having several instead of one or two a year. The Missions/Evangelism team will be looking into possibly promoting the idea to the churches.

Brother Steven Nichols shared his vision of having a Cadiz 2020 Crusade, with Steve Hale as the evangelist. He shared his ideas for the crusade and asked for the support of the committee to continue. The committee unanimously gave support to proceed with plans for the campaign. The committee also discussed the possibility of using the 2019 mission offering to help with this endeavor.

May 6, 2019 Meeting

Old Business: Evangelism/Missions team leader Steven Nichols presented to the team to continue "Revival Fires," through the church prayer partner rotation, by partner churches pairing up to have a Revival Fires meeting during the 3rd quarter of the rotation. He also shared that Evangelist Steve Hale had agreed to be the preacher for Cadiz 2020 Crusade. Both items will be presented to the Mission Board as a motion.

New Business: Brother Steven Nichols presented the proposal from the DOM/AMS Search Committee for the DOM/AMS salary package, with changes to the vacation time to be (2) weeks beginning the first year. It would be prorated depending on what date he would start. Committee would bring as a motion to the Mission Board.

The committee discussed having monthly meetings instead of quarterly meetings until a new Director is called. The monthly meeting will allow the Ministry Assistant to address issues with the team.

Incorporation filling was discussed, which will be due June 30th. The registered agent would need to be changed due to the absence of a Director. The committee determined it might be best to change the registered agent to Shari Littlejohn, Ministry Assistant so that a change would not have to be made again until the next year following the call of a Director. A motion was made and seconded to allow Shari to be listed as the Registered Agent. Motion carried.

Annual Meeting Planning: The 2018 program was given to the team to look over and bring back ideas for the planning. It was discussed to continue to have on the third Sunday as to not conflict with Fall break nor Ham Festival weekend. Will secure a date during our calendar planning in July. A host church is needed and limited to which church can host due to the size of the meeting. Would like to have centrally located this year since we have had on each end of the county recently. Will possibly contact Liberty Point BC for hosting.

Trustees reported the glass front doors on the center to be replaced 5/7/19. Looking at replacing the other metal front doors with new doors, and moving the existing metal front doors to the rear of the building. Asking for volunteers to help with adding a new driveway next week for more accessible parking for the Block Party trailer as well as the van. Trees will need to be taken down to accommodate a driveway. The Disaster Relief trailer has been moved from Liberty Point Baptist Church to Cadiz Hardware. All equipment is being checked out by mechanics and will be put back on the trailer to be stored somewhere in the county.

Encouraging/Empowering team leader, Joe Johnson, reported that 75 attended the National Day of Prayer.

Orville Herndon spoke to the team about the discouragement of the attendance for the annual VBS Clinic. There were only 33 in attendance, and those on the team put a lot of work into the training. We will need to relook at this event, as well as the January Bible Study Preview and see if we can get some feedback from the churches on what they would like to see.

Pastor Steven Nichols shared with the team that Evangelist Steve Hale had committed to the Cadiz 2000 Crusade, and the team was in agreement to continue plans to have the crusade possibly sometime in the fall of 2020. He also reported that the Alaska airline tickets were purchased and everything was okay.

June 3, 2019 Meeting

Old Business: The DOM search team met with the Executive Team to share the new DOM/AMS salary package, as they have a candidate to present as DOM/AMS. This was presented as a motion from Pastor Steven Nichols, chairman of the DOM/AMS search team, to submit to the Mission Board for approval. The total package to be \$59,947.00, to be divided as candidate deems necessary. Encourage/Empower Assistant Team Leader Bruce Wynn seconded the motion, motion carried. Pastor Steven shared with the team that we will be receiving \$1,000.00 per month through the AMAP assistance from the KBC. We will need a request from the Mission Board, recorded in the minutes to apply for assistance. Pastor Steven also shared with the team that the search team would be presenting the candidate during a unique called worship service on Thursday, June 20, 6:30 p.m., at Cadiz BC. The meeting will be a worship service, with music led by Derek Niffenegger, and the candidate will preach. We will then have a time of question & answer, with voting to follow. The candidate's name will be released soon.

Pastor Steven Nichols nominated Pastor Kirk Greenfield to serve as the assistant Evangelism/Mission Team Leader. The Executive Team agreed and will be presenting the nomination to the Mission Board.

Encourage/Empower Assistant Team Leader Bruce Wynn nominated Pastor Calvin Bryant to serve as the Encourage/Empower Team Leader. The Executive Team agreed and will be presenting the nomination to the Mission Board.

Annual Meeting planning continued with the agreement to hold the Annual Meeting on Sunday, October 20, 5:00-8:00 p.m. The team was in agreement to ask Liberty Point BC to host the meeting. We will continue with the meal following the business part of the meeting. Ann Schisler will be contacting Liberty Point to see if they are willing to host. Will continue with the program planning at a later date to have input from a new DOM/AMS if called.

New Business: Sister Shari Littlejohn shared her concerns for the associational van due to the recent change to teams. There was a van committee in place that was responsible for the van at that time. There have been some issues with cleaning of the van for quite some time, and she asked for someone to be in charge of the van. Pastor Tim Smith, LRBA moderator, shared that the responsibility would fall to the trustees as part of the property. Pastor Brad Chalfin will stress the guidelines during the Mission Board Meeting to reinforce the penalty for not cleaning or fueling. The Block Party trailer and box trailer would also fall under the responsibility of the trustees and have been having issues with churches not filling out the required paperwork in the Block Party Trailer. Pastor Brad Chalfin will also address to the Mission Board.

July 1, 2019 Meeting

Old Business: The trustees presented the following: 1) Equipment was checked in the Disaster Relief Trailer and is in bad shape. They feel all gas equipment needs to be sold, as well as non-gas tools not used by Camp Cadiz. Camp Cadiz has asked for the Disaster Relief trailer to be converted to a shower trailer to be used during Camp Cadiz. Bob Brame stated that he had contacted the KBC and they would supply a \$2000.00 grant for the conversion if considered for Disaster Relief. The trailer has over 20,000 miles but could sell for \$2,500.00-\$2,900.00 as is. After much discussion, the trustees recommended keeping the Disaster Relief trailer for Associational use, including Camp Cadiz, and selling the current Camp Cadiz trailer. The Disaster Relief trailer would be much better suited for Camp Cadiz use. They also recommended selling all equipment as is, that the Association does not deem necessary. Motion carried.. 2) Bid for parking lot repair was presented at \$23,985.00, shared that the Oneida trailers were causing much damage to the parking lot as well as trash pick-up. Shari will be taking trash out to the road each week for pick-up. She may call upon trustees to help as she wishes. 3) Care of the associational van was discussed at length, but could not find the right answer to the solution at this time.

New Business: 1) Liberty Point has asked to use the large meeting room for their Youth VBS the week of July 8-12. This was brought as a motion and carried. 2) Sister Louise Fuller shared her concerns about someone heading up the Bible Study rotation at the Sr. Citizen's Center. There are several pastors on the rotation list, but there have been several weeks in which no one was there. It was decided to let those on the rotation list continue to oversee. 3) Brother Bruce Wynn presented a request from a couple serving at Ponderosa to have a live Nativity Scene, but need help from individuals and churches. No action was taken at this time. 4) The current DOM/AMS search committee would need to be resolved due to the calling of Bro. Bobby Sellers as new DOM/AMS. This will be presented for vote at the Mission Board meeting.

August 5, 2019 Meeting

Old Business: The committee met to finalize the Annual Meeting. The event will be Sunday, October 20, beginning at 5:00 p.m., at Liberty Point. The business and worship service will take place in the Family Life Center, and the meal in the fellowship hall. The committee was in agreement to ask Brother Derek Niffenegger of Cadiz Baptist Church to lead in the Call to Worship for 15 minutes. Eric Allen (Missions Mobilization Team Leader) will be our KBC speaker, with a total of 20 minutes on the program. Director of Missions, Bobby Sellers, will do the final message before special music allowing 20-25 minutes. It was agreed to ask someone from the host church to present special music. Mrs. Ruby Martin suggested a group from Liberty Point, and the team affirmed. The group would be asked to perform two songs. Mrs. Emma McBride would be asked to lead in a hymn during the business portion to the meeting. Goodwin Funeral Home has agreed to furnish the Barbecue for the meal, and Kings Funeral Home the desserts. The team discussed staying within time constraints to end the meeting at 8:00 p.m. Jerry Schisler informed the committee that the Camp Cadiz trailer and equipment sold for \$3,000.00 and that the Disaster Relief trailer would be used for Camp Cadiz or associational use by the churches.

New Business: Shari Littlejohn, requested that the annual 2018-2019 annual report will be dedicated in memory of Bro. Norman Ellis. The team unanimously approved the request. Budget/Calendar Planning Meeting set for August 22, 6:00 p.m. The committee also discussed the need to find someone to serve as Youth Leader for the association.

Sunrise Children's Services Report

Sunrise has worked to preserve, protect, and promote the "Forever Family" mindset since their very beginning in 1869. 2019 marks our 150th Anniversary of meeting the needs of the most vulnerable children in the Commonwealth of Kentucky. Originally, they were called to provide protection and



hope to orphans living on the streets of Louisville. Today, that ministry mindset has grown to encompass every level of care both in and out of the home. This is accomplished through the Foster-to-Adoption ministry, where they connect families who are called to open their hearts and homes to a child in need.

You may know Sunrise as "Kentucky Baptist Homes for Children." That is certainly where they began. By God's grace, their ministry towards children, youth, and families has deepened and expanded. Today, they are one of Kentucky's oldest and largest child care nonprofit organizations providing six therapeutic residential treatment programs, professional care for families in crisis, therapeutic foster care, foster-to-adopt, and a proven transition program for those aging out of

foster care. They are changing the way child welfare is done, for the better. While the name may have changed, the mission remains clear: To provide care and hope for hurting Kentucky families and children through Christ-centered ministries.

Since the inception of the foster-to-adoption program in 2006, Sunrise Children's Services has celebrated more than 400 adoptions. There are few more significant ways to care for a child than to take him into our home and give him a family. Children waiting in the U.S. foster care system age from infant to young adults. The average age for Sunrise kids is 11. Many of these children have siblings in the system and they shouldn't be separated. Most foster children are perfectly healthy children who simply need and deserve loving and supportive adults in their lives.

Sunrise is committed to providing and maintaining quality foster homes and parents, as well as strong quality therapeutic foster homes where they are needed. Foster parents receive professional training and ongoing support from the staff at Sunrise.

There are many ways that you can help meet the needs of the children that are being served through Sunrise Children's Services:

FOOD ROUND UP

It is no small task to feed over 130 children in our 6 Residential Treatment Facilities. Each child is provided 3 meals a day, and 2 snacks. The federal government provides for breakfast, lunch, and 1 snack daily. Sunrise must make up about \$1.50 per child daily to meet the balance of the cost. If you would like to help, you can purchase gift cards (preferably from Wal-Mart or Kroger's), designated specifically for the Sunrise Food Round Up, and mail them to Sunrise Food Round Up, Sunrise Children's Services, P.O. 
MILES OF PENNIES





Little River BAPTIST ASSOCIATION

Serving The Church. Serving The Kingdom.

CONSTITUTION

ARTICLE I – NAME

This body shall be called the “Little River Baptist Association.”

ARTICLE II – PURPOSE

The purpose of this body shall be for the education, inspiration, and promotion of the proclamation of the gospel of Jesus Christ at home and abroad, and to uphold the doctrines and principles common to Southern Baptists and to encourage the churches in their loyalty and practice of these doctrines and principles.

ARTICLE III – AFFILIATION

Section 1. Any church desiring to affiliate with this body shall submit a petition to the Association through the Credentials Committee (Executive Team) along with a statement of their history, articles of faith, and cooperative intent. The findings of this committee shall be presented to the Association or its Mission Board. If approved by the Mission Board the church shall be accepted on a non-voting cooperative basis pending action of the next annual associational meeting.

Section 2. Any church failing to report at the annual associational meeting or to contribute financially to the work of the Association for two (2) successive years or to uphold the doctrines and principles according to the Baptist Faith and Message as adopted by the Southern Baptist Convention in 2000, shall be investigated by this body, and any church thus investigated and failing to meet these requirements during the following associational year shall be discontinued as a member of this Association.

ARTICLE IV – MEMBERSHIP AND REPRESENTATION

Section 1. This body shall consist of messengers elected by the churches affiliated with this Association along with the Associational Missionary, general officers, trustees, team leaders/assistants, the pastor of each affiliated church, and Mission Board member.

Section 2. Each church is entitled to three (3) messengers for the first one hundred (100) members or less, and one (1) messenger for each additional one hundred (100) or major fraction thereof. No church shall have more than ten (10) messengers.

ARTICLE V – MEETINGS

Section 1. The Association shall meet semi-annually (in April & October) or at such time and place as shall be chosen by this body.

Section 2. In case of an emergency requiring a change of place and/or time of annual meeting, the Mission Board of the Association shall make necessary changes.

ARTICLE VI – OFFICERS AND TEAMS

Section 1. The general officers of this body shall be a Moderator, Assistant Moderator, Clerk, Assistant Clerk, Treasurer, and Assistant Treasurer. Term of each office is one (1) year. The Moderator shall not serve more than two (2) successive terms. Election of each general officer must be considered separately.

Section 2. The team leaders/assistants shall be elected during the April meeting of the Little River Baptist Association.

Section 3. The Association shall elect such teams as seems wise for the proper functioning of its work.

Section 4. There shall be elected three (3) associational trustees for legal purposes. Representatives may be elected to represent this Association with other bodies.

Section 5. The Association may have a person serving as Associational Missionary. His “Call” shall be for an indefinite period. Other salaried persons may be secured if the body deems wise.

Section 6. At the annual associational meeting each year before the election of personnel, this body shall adopt “Job Descriptions and/or Guidelines” for each general officer, trustee and team member. These take effect at the close of said meeting and continue until new ones are adopted. They shall be printed in the associational minutes as considered necessary.

ARTICLE VII – MISSION BOARD

Section 1. The Mission Board shall consist of the general officers of the Association, the Associational Missionary, all other elected team leaders, trustees, the pastor or interim pastor and one lay member elected by each affiliated church.

Section 2. Between annual meetings of the Association the business shall be carried on by the Mission Board.

Section 3. The general officers of the Association shall be the officers of the Board.

Section 4. The Board shall meet monthly with exception of the month in which the annual Association meets. Nine members shall constitute a quorum.

ARTICLE VIII – AUTHORITY

This Association is an autonomous body and therefore reserves the right to determine its own policies and to direct its own business; however, it shall not exercise any ecclesiastical authority over the affiliated churches, but is an advisory and coordinating body and may only recommend, advise, and urge the importance of cooperative Christian activity.

ARTICLE IX – RULES OF ORDER

The body shall be governed by the rules of order outlined by ROBERT’S RULES OF ORDER.

ARTICLE X – AMENDMENTS

The constitution may be amended at any regular session of the semi-annual or annual associational meeting by two-thirds of those members voting, provided notice of such amendment had been presented in writing at the previous semi-annual or annual meeting.

GUIDELINES

GENERAL PROVISIONS

All general officers, trustees, team leaders, assistant team leaders along with others serving in a leadership role, etc., are under the direction of and directly responsible to the Association* for the performance of duties as listed in his or her given area. No authority is granted to any individual or group to take any action or make any expenditure except as clearly indicated by Association action. Persons unable to attend scheduled meeting may be relieved and replaced. Replacement to be for unexpired term only. The associational year shall be September through August. **

(*) The word "Association" as used herein includes the Mission Board which is responsible for carrying on the business of the Association between the semi-annual meetings.

(**) See Robert's Rules of Order" for additional details.

GENERAL OFFICERS

The election of general officers shall be at the April meeting of the Association. They shall take office as the close of the October meeting and serve until the close of the next October meeting.

I. MODERATOR: The Moderator shall preside at all meetings of the Association and the Mission Board, abiding by the Constitution and designated rules of order so as to cause proper functioning of all business matters, always maintaining order and the best possible fellowship. He is ex-officio member of all organizations of the Association. He may resign his duty either temporarily, or permanently to the next officer under him that is present. The moderator shall not serve more than (2) successive terms.

II. VICE MODERATOR: In the absence of, or at the request of the Moderator, the Assistant Moderator shall assume the responsibilities of the Moderator. He shall serve as Chairman of the Executive Team.

III. CLERK: The Clerk shall:

1. Make and keep adequate and permanent records of all sessions of the semi-annual meetings of the Association. Prepare the same for print, seeing that they are printed and distributed to the churches.
2. Make and keep adequate typewritten records of all meeting of the Mission Board distributing a copy of each, to the Associational Missionary, the Moderator, and the Assistant Moderator.
3. In the event of expected absence at any meeting he shall ask the Assistant Clerk to serve.
4. Be responsible for associational correspondence.
5. Prepare a digest of church letters for presentation at the October associational meeting.

- IV. ASSISTANT CLERK: The Assistant Clerk shall perform the duties of the Clerk when requested.
- V. TREASURER: The Treasurer shall:
1. Keep a permanent record of all money received for associational purposes, and of all expenditures, using associational recommended and/or approved forms.
 2. Prepare monthly typewritten reports to the Association and an annual report for the October associational meeting.
 3. Disburse funds only according to the budget, or upon action of the Association.
 4. Permit audit of Treasurer's books as desired by the Association.
 5. For financial accounting purposes, the associational year shall be January 1 through December 31. Cut-off date, for both monthly and annual reports, shall be the 25th day of the calendar month applying. Receipts and expenditures occurring after the 25th of the month will be shown on the next month's report.
- VI. ASSISTANT TREASURER: The Assistant Treasurer shall perform the duties of the Treasurer when requested.



ORGANIZATIONAL PERSONNEL

EXECUTIVE TEAM

There shall be an Executive Team. This team will function in an administrative role for our association. This team will be made up of the general officers of the association as well as the team leaders of all ministry teams. This team will meet quarterly to coordinate the following work and plans of the association:

1. Prepare the annual budget
2. Plan the annual & semi-annual meetings
3. Serve as what was formerly the credentials committee in handling requests of churches to join our association.
4. Nominate team leaders

TRUSTEES

The Association will have a total of (3) trustees. All future trustees shall be elected to serve from the end of the current annual meeting to the end of the next annual meeting. The trustees will serve by carrying out the following:

1. Supervise the care of associational owned property.
2. Review property at least once a calendar quarter, and recommend necessary repairs, changes, improvements, etc., so that the best use of the property may be had, and that its value may be maintained.
3. Sign legal documents as are expressly ordered by the Association.

WMU LEADERSHIP TEAM

The WMU Director and her Leadership Team will work closely with the Associational Missionary in the planning & calendaring of associational WMU activities. The director shall make a monthly report to the Mission Board.

YOUTH COUNCIL

The Youth Director and council will work closely with the Associational Missionary in the planning and calendaring of associational youth activities. The director shall make a monthly report to the Mission Board.

MUSIC

The Music Director and pianist will work closely with the Associational Missionary in the planning and calendaring of associational music events.

MINISTRY TEAMS

Team leaders, and assistant team leaders will be elected for each ministry team. The association may have as many teams as deemed necessary to carry out the work of the association. Each team will recruit their own team members. Team leaders will have a (3) year term limit, and assistant leaders will have a (4) year term limit. These leaders are to be elected for those terms at the Semi-Annual meeting following the election of General Officers. The nomination of team members will be presented by the Executive Team.



EQUIPPING TEAM (Equip Acts 2:42)

This team will assist, encourage, and resource churches to become healthy strong congregations as well as helping the leaders of each church to grow in their relationship with the Lord and to grow in their leadership skills for their area of ministry. This team serves churches by providing relevant resources, customized training and consulting that assist in developing the overall health and growth of churches (Examples: Sunday School, Vacation Bible School Clinics, Children and Youth ministries, etc.) This team will facilitate training, resources, support networks and professional development as well as emotional and spiritual health for pastors, staff, ministry leaders, their wives and families. They will work closely with the Executive team in planning and calendaring of activities. They should report each month to the Mission Board as well as prepare a printed yearly report for the annual report to be submitted at the October annual meeting.

EVANGELISM/MISSIONS TEAM (Evangelism Acts 4:12)

This team will assist, encourage, and resource churches to start new works that reach the lost and unchurched of our area as well as helping the churches of the Little River Baptist Association to be on mission with Christ through evangelism and mission opportunities. This team identifies and assists in starting and developing strategies to reach new people as well as the development of mission work locally, regionally, nationally, and globally. It works to coordinate partnerships, resources, personnel and training workers for church planting, missions, and evangelism. They should report each month to the Mission Board as well as prepare a printed yearly report for the annual report to be submitted at the October annual meeting.

ENCOURAGE AND EMPOWER TEAM (Empower Acts 1:14; Encourage Acts 14:21-22)

This team will encourage and empower our churches and leaders. The empowering is a focus on prayer because we know that apart from a move of Go0d we have no power ourselves. This team will implement a plan to encourage not only our local churches and pastors, but also seek ways to encourage NAMB church planters as well as IMB missionaries. They will also develop a prayer focus and strategy for our association. They should report each month to the Mission Board as well as prepare a printed yearly report for the annual report to be submitted at the October annual meeting.

AUXILLIARY TEAM MEMBERS

The Associational Trustees, WMU Director, Youth Director and Music Director are considered auxiliary members of the ministry teams. They should report each month to the Missions Board as well as prepare a printed yearly report for the annual report to be submitted at the October annual meeting.
