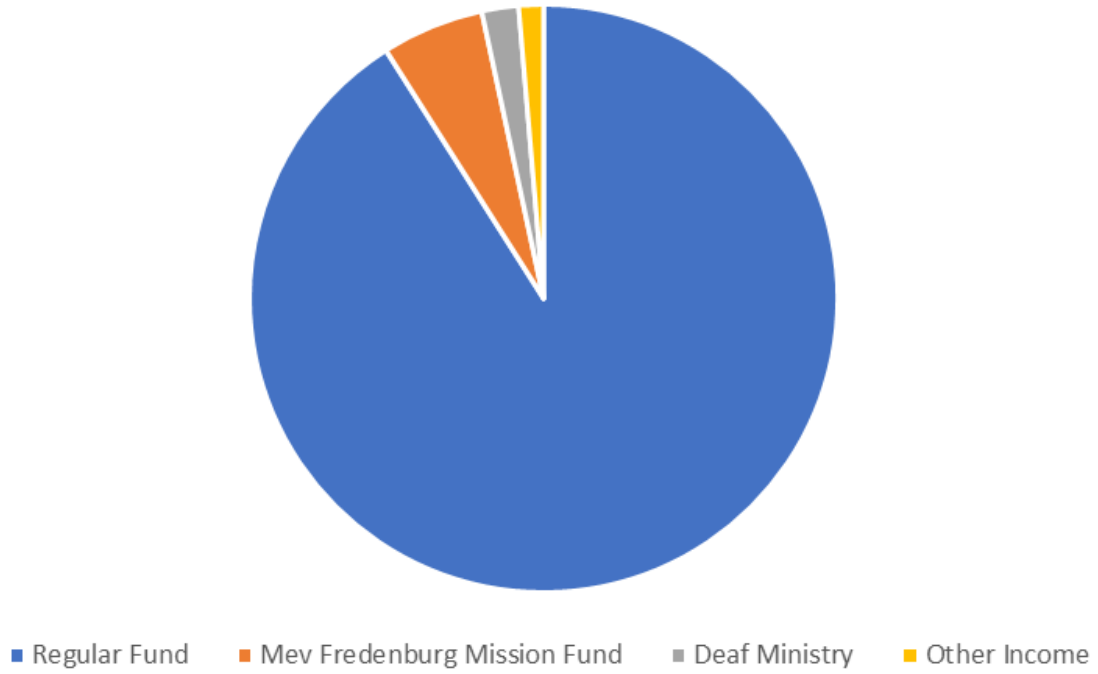

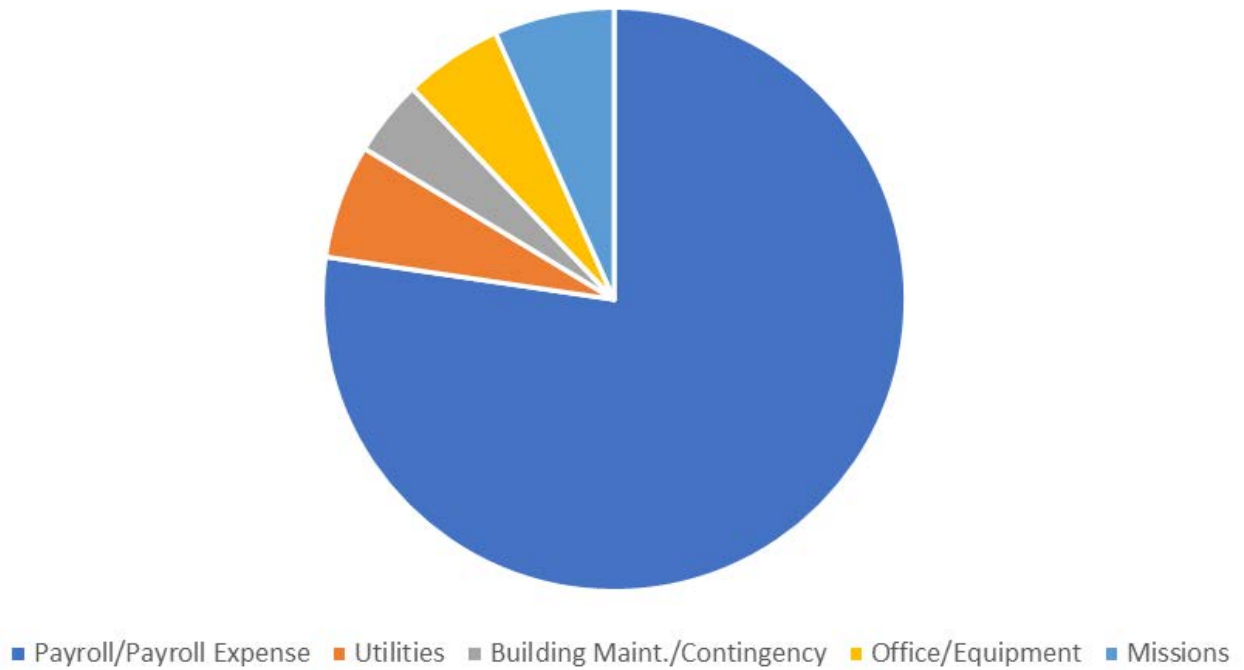

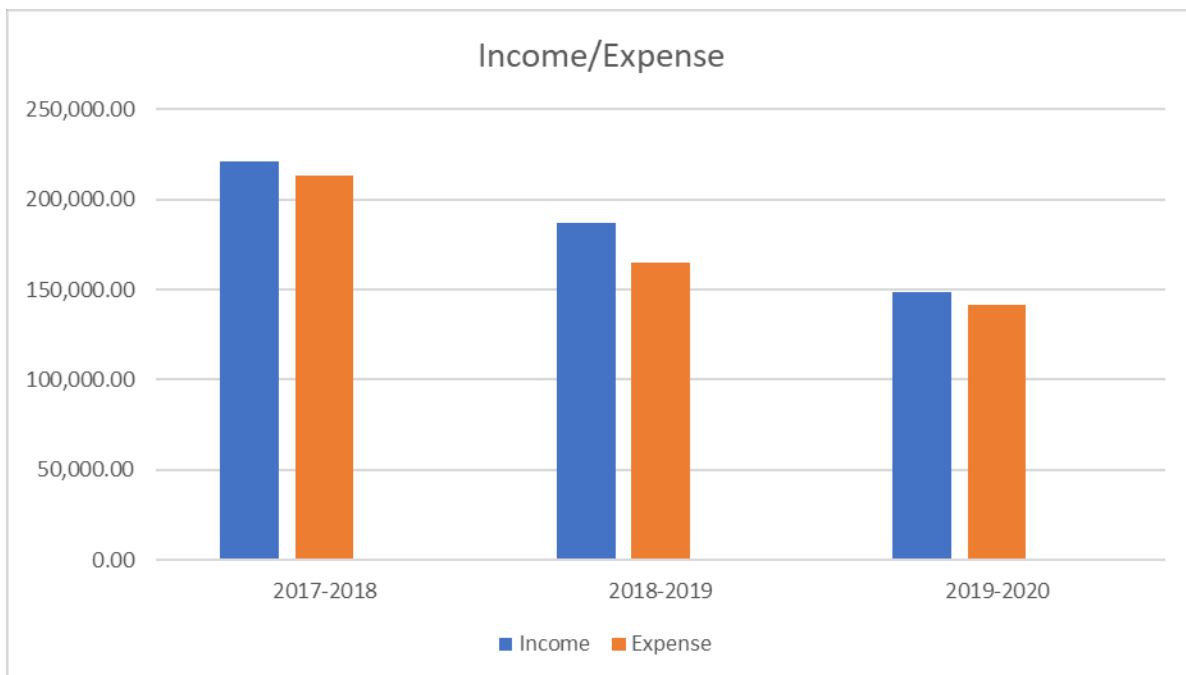

Executive Team Meeting 9/9/19

Present at the meeting: Brad Chalfin, Bobby Sellers, Joe Johnson, Bruce Wynn, Kirk Greenfield, Orville Herndon, Tim Smith, Louise Fuller, Jerry Schisler, Ann Schisler, Shari Littlejohn, Ruby Martin.

The committee met to finalize the 2020 calendar. Bro. Bobby Sellers suggested that he would like to see the March Mission Board Meeting reinstated. Currently there is no March meeting due to the West Kentucky Evangelism Conference on 1st Monday in March. He felt the Mission Board needed to meet the Tuesday following the Evangelism Conference. He also suggested that the Mission Board be cancelled the month of November due to the Annual Meeting being held later in October. The committee was in agreement to make a recommendation to the Mission Board to reinstate the March meeting on the Monday following the West KY Evangelism Conference. It was also agreed upon to recommend cancelling the November Mission Board Meeting. This would have to be a change in the Constitution and would need to be presented at the Annual Meeting, with the vote to be taken at the following Semi-Annual Meeting in April 2020. Orville Herndon expressed that he would get with Bro. Bobby Sellers to complete the wording for presenting a Constitution change.

Discussion was also held concerning a donation to the AB Colvin Mission Fund, of which Bro. Bobby would be requesting a grant for Camp Cadiz. This comes from the Kentucky Fellowship of Directors of Missions. The recommended donation is \$100.00. Bro. Bobby felt if we were requesting a grant then we should be donating to the fund. The committee unanimously voted to give the \$100.00 donation.

Discussion was held concerning the Trigg County Bi-Centennial History Book. The Historical Society is asking for church histories to be published in the book edition. Shari asked for permission to submit a full-page history of LRBA, costing \$125.00, which would come from the office budget. The committee unanimously voted to publish the history.

Jerry Schisler commented on the tabled motion of the sale of the property. The trustees have decided not to recommend sale of the property.

The trustees are recommending a \$75.00 charge from the churches for the use of the van. This will help in the future maintenance and repair of the van. The churches will continue to clean and fuel the van along with the \$75.00 charge.

The following were in attendance: Steven Nichols, Bruce Wynn, Bobby Sellers, Kirk Greenfield, Calvin Bryant, Jerry Schisler, Ann Schisler, Orville Herndon, Louise Fuller, Shari Littlejohn.

The committee met to plan the Semi-Annual Meeting to be held, April 20, at Oak Grove BC. Bro. Steven Nichols will be contacting Bro. Nick Clark, host church pastor. Bro. Nick will welcome the association along with Bible reading & prayer. He will be asked to provide special music within the host church. Mrs. Emma McBride will be asked to lead the music. The team was unanimous in selecting Bro. Daniel Colley to bring the message and Bro. Justin Silvers to serve as alternate.

Other business:

Vacancies for youth, assistant equipping team, and assistant encourage/empower team leaders were discussed. Names were not suggested, but was agreed upon to send out information to the churches about these positions, requesting names for filling these vacancies. Information will be presented at the March meeting as well. Nominations will need to be submitted at the Semi-Annual meeting in April, unless filled prior to the meeting.

Bro. Bobby Sellers shared that he would like to work with teams to help churches in dealing with issues such as abuse, safety, etc.

Bro. Calvin Bryant shared that he and Bruce Wynn were currently looking at getting pastors together for the purpose of helping churches with visitation, and asked for prayer concerning motivating visitation in the churches.

Mission trip expenses for the DOM/AMS were discussed. The current job description states that expenses will be provided for the DOM while on associational mission trips. Bro. Kirk Greenfield suggested mission trip expenses be paid not only for the DOM/AMS, but also for his spouse if attending. This would need to be presented to the association with appropriate changes to that description.

Due to the limited amount of time for attending the Mission Board Meeting, the team agreed to set an additional meeting date, February 25, 2020, 7:00 p.m., at the Baptist Center. Discussion will be held concerning Executive Team meetings held on different evenings than Mission Board Meetings, due to the time restraints.

Motion was made by Bruce Wynn to present the following change at the Semi-Annual Meeting: Change to Article VII- Mission, Section 4 to read: The Board shall meet on a monthly basis, or as often as the Executive Committee deems necessary, with the exception of the month of the Annual Meeting. Mission expense for the DOM & spouse was discussed. The current job description states that expenses for the Associational Missionary will be provided for while on Associational Mission trips. The team felt that the spouse should be provided for as well. After much discussion and recommendation by Bro. Bobby Sellers, motion was made to make no changes, and to just consider on a case by case situation, as to the current budget situation. Motion carried.

Team vacancies were discussed and a motion was made to ask Bro. Tim Smith to lead as Youth Leader for the association, and to ask Bro. Justin Silvers to possibly assist in this area of ministry. They would be nominated during the Semi-Annual meeting if in agreement. Motion carried. A second motion was made to nominate Bro. Calvin Bryant as Equipping Team Leader; and Orville Herndon as Encourage/Empower Team Leader. Motion carried.

The 2020 Mission Offering promotion & goal was discussed. After much discussion, the committee agreed to wait on more plans for the 2020 Crusade to recommend a goal.

New Business:

The possibility of purchasing a new associational van was discussed. More discussion about the van to be brought up at the Semi-Annual Meeting in April.

Executive Team meeting dates were discussed. It was decided to meet during the March 9th, Mission Board Meeting at New Hope BC, 6:00 p.m., for discussion during the meal. It was also decided to meet, if needed, on April 13, 6:30 p.m., at the Baptist Center.

The Executive Team met by Zoom video conferencing, due to the Governor's order to cease gatherings to slow the spread of COVID-19. The team met for the purpose of the discussion and action on the following events: Semi-Annual Meeting scheduled for April 20th; Alaska Mission trip scheduled for July 14-21; and Camp Cadiz scheduled for June 21-25.

The committee discussed the Semi-Annual Meeting briefly, and all were in agreement the meeting would have to be cancelled, as would all gatherings in the month of April. Bro. Kirk Greenfield made a motion to cancel the Semi-Annual Meeting scheduled for April 20th. Motion was seconded and carried.

Bro. Steven Nichols shared with the committee his concerns with the Alaska Mission trip scheduled for July 14-21. He has contacted Alaska Missions, but at this time has not had any correspondence with them since the COVID-19 pandemic. He was concerned about purchasing the airline tickets in May, and had spoken with many of the team concerning the situation. He stated that most were comfortable with cancelling due to the circumstances. Bro. Steven made a motion to cancel the 2020 Alaska Mission trip with the potential of a 2021 trip. Motion was seconded and carried.

A lengthy discussion was held about the June 21-25, Camp Cadiz. The team discussed possibly waiting to make a decision, but with the planning that must go into Camp Cadiz, it may be difficult. We are still unsure where we will be in June with COVID-19. After much discussion, the team felt that it would be best to cancel. Bro. Brad Chalfin made a motion to cancel. The motion was seconded and carried. The team then discussed the possibility of needed projects that could potentially be done by small groups from the churches, and by possibly doing something in the Fall.

The National Day of Prayer for May 7th, was also discussed with the possibility of broadcasting instead of gathering. The team did not make a decision at this time, but agreed to talk with WKDZ about the possibilities.

Lastly, it was discussed to have our next meeting sometime in May, by video conferencing as well. Bro. Bobby Sellers will get with the team about scheduling another meeting. The team was scheduled to meet on May 4th, prior to the Mission Board at Ponderosa, but no decision was reached on the May meeting.

Little River Association was approved through Farm Bureau Bank for approximately \$7,000.00, to pay the ministry assistant's salary for 2.5 months during the COVID-19 pandemic. This is a no interest loan offered by the Small Business Administration in order to continue to keep employees during this difficult time. The loan is not required to be repaid as long as you use the loan for the salary. After much discussion from the committee, Bro. Calvin Bryant made the motion not to accept the loan. The motion was seconded and carried.

Association Missionary Assistance Program- Mrs. Shari Littlejohn shared with the committee that in order to continue the KBC Salary assistance for the Director of Missions, we would need to vote in order to continue each year. Due to the fact that the Mission Board is not meeting during the pandemic, the Executive Team would need to carry on the business of the Association. Bro. Kirk Greenfield made a motion to continue the assistance for the next year of \$800.00 per month. Motion was seconded and carried.

Bro. Kirk Greenfield asked others to share what plans they had about returning to in-person worship at each of the churches in light of COVID-19. Some shared plans to return May 24th, with strict cleaning, and limited services. Ponderosa has made the decision to wait until July to reopen, and others awaiting a meeting with church leaders to make their plans.

Bro. Bobby Sellers shared that the association purchased cases of liquid sanitizer which can be sprayed as a mist and does not need to be wiped. These are available for churches to purchase @ \$20.00 1/2 gallon bottle or for \$120.00 for a case of 6- 1/2 gallon bottles. Orville Herndon suggested that churches not use the spray on their sound/technical equipment.

Prayer requests were given along with praises. Orville Herndon moved to adjourn, and Bruce Wynn closed in prayer.

Executive Team Meeting 7/6/20

The Executive Team met for the purpose of planning the Annual Meeting, to be held October 18, 2020.

Mrs. Ann Schisler led in prayer.

The team discussed what facilities would be best to host the meeting due to COVID-19. Cadiz Baptist Church had initially volunteered to host the meeting, but the team felt a larger Family Life Center may be best for meeting if social distancing guidelines were still in place. Orville Herndon made a motion to ask Locust Grove to host the meeting in the Family Life Center, to thank Cadiz for their offer, and ask if they would be willing to host the 2021 meeting instead. Motion was seconded and carried. Bro. Bobby Sellers agreed to contact Locust Grove and Cadiz BC.

The team then discussed options for having a meal. After much discussion and reservations about having a full meal, it was discussed to begin the meeting at 3:00 in the afternoon and end by 5:30. The team discussed the bylaw amendment that was supposed to be presented at the Semi-Annual meeting in April. Since the cancellation of that meeting it would need to be presented at the Annual Meeting in October.

Motion was made to pay Shari Littlejohn the amount that Regina Hall was being paid for cleaning services. Motion carried.

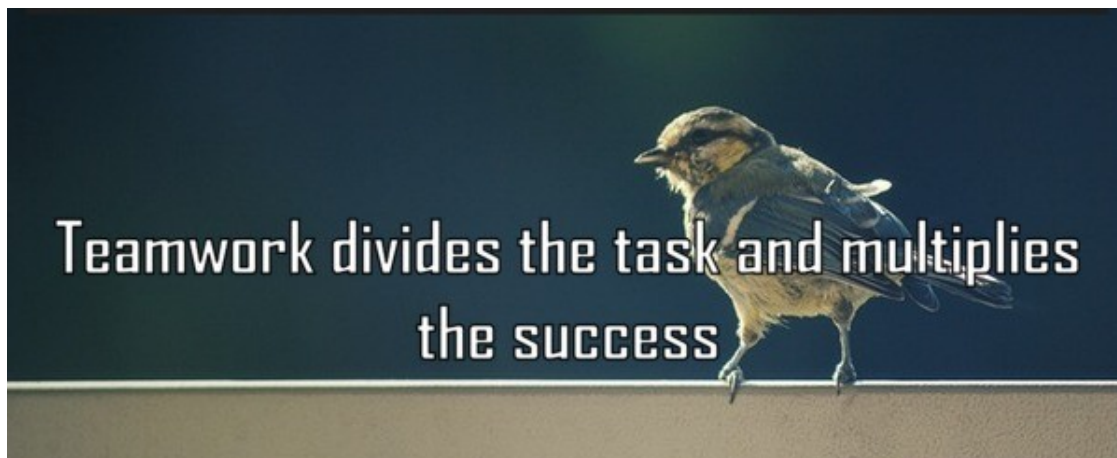

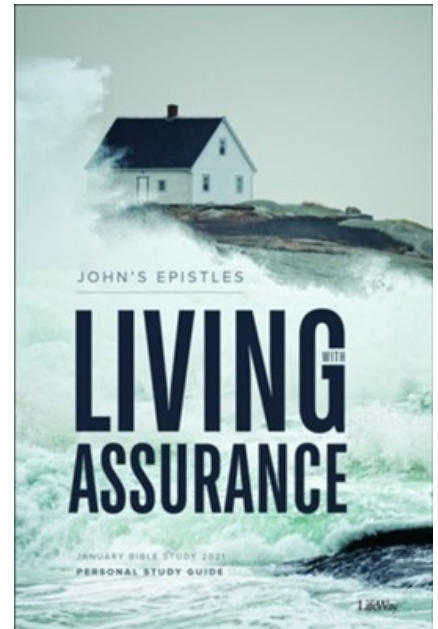
Equipping Team Report 2019-2020

CONSTITUTION

ARTICLE I – NAME

This body shall be called the “Little River Baptist Association.”

ARTICLE II – PURPOSE

The purpose of this body shall be for the education, inspiration, and promotion of the proclamation of the gospel of Jesus Christ at home and abroad, and to uphold the doctrines and principles common to Southern Baptists and to encourage the churches in their loyalty and practice of these doctrines and principles.

ARTICLE III – AFFILIATION

Section 1. Any church desiring to affiliate with this body shall submit a petition to the Association through the Credentials Committee (Executive Team) along with a statement of their history, articles of faith, and cooperative intent. The findings of this committee shall be presented to the Association or its Mission Board. If approved by the Mission Board the church shall be accepted on a non-voting cooperative basis pending action of the next annual associational meeting.

Section 2. Any church failing to report at the annual associational meeting or to contribute financially to the work of the Association for two (2) successive years or to uphold the doctrines and principles according to the Baptist Faith and Message as adopted by the Southern Baptist Convention in 2000, shall be investigated by this body, and any church thus investigated and failing to meet these requirements during the following associational year shall be discontinued as a member of this Association.

ARTICLE IV – MEMBERSHIP AND REPRESENTATION

Section 1. This body shall consist of messengers elected by the churches affiliated with this Association along with the Associational Missionary, general officers, trustees, team leaders/assistants, the pastor of each affiliated church, and Mission Board member.

Section 2. Each church is entitled to three (3) messengers for the first one hundred (100) members or less, and one (1) messenger for each additional one hundred (100) or major fraction thereof. No church shall have more than ten (10) messengers.

ARTICLE V – MEETINGS

Section 1. The Association shall meet semi-annually (in April & October) or at such time and place as shall be chosen by this body.

Section 2. In case of an emergency requiring a change of place and/or time of annual meeting, the Mission Board of the Association shall make necessary changes.

ARTICLE VI – OFFICERS AND TEAMS

Section 1. The general officers of this body shall be a Moderator, Assistant Moderator, Clerk, Assistant Clerk, Treasurer, and Assistant Treasurer. Term of each office is one (1) year. The Moderator shall not serve more than two (2) successive terms. Election of each general officer must be considered separately.

Section 2. The team leaders/assistants shall be elected during the April meeting of the Little River Baptist Association.

Section 3. The Association shall elect such teams as deems wise for the proper functioning of its work.

Section 4. There shall be elected three (3) associational trustees for legal purposes. Representatives may be elected to represent this Association with other bodies.

Section 5. The Association may have a person serving as Associational Missionary. His “Call” shall be for an indefinite period. Other salaried persons may be secured if the body deems wise.

Section 6. At the annual associational meeting each year before the election of personnel, this body shall adopt “Job Descriptions and/or Guidelines” for each general officer, trustee and team member. These take effect at the close of said meeting and continue until new ones are adopted. They shall be printed in the associational minutes as considered necessary.

ARTICLE VII – MISSION BOARD

Section 1. The Mission Board shall consist of the general officers of the Association, the Associational Missionary, all other elected team leaders, trustees, the pastor or interim pastor and one lay member elected by each affiliated church.

Section 2. Between annual meetings of the Association the business shall be carried on by the Mission Board.

Section 3. The general officers of the Association shall be the officers of the Board.

Section 4. The Board shall meet monthly with exception of the month in which the annual Association meets. Nine members shall constitute a quorum.

ARTICLE VIII – AUTHORITY

This Association is an autonomous body and therefore reserves the right to determine its own policies and to direct its own business; however, it shall not exercise any ecclesiastical authority over the affiliated churches, but is an advisory and coordinating body and may only recommend, advise, and urge the importance of cooperative Christian activity.

ARTICLE IX – RULES OF ORDER

The body shall be governed by the rules of order outlined by ROBERT’S RULES OF ORDER.

ARTICLE X – AMENDMENTS

The constitution may be amended at any regular session of the semi-annual or annual associational meeting by two-thirds of those members voting, provided notice of such amendment had been presented in writing at the previous semi-annual or annual meeting.

GUIDELINES

GENERAL PROVISIONS

All general officers, trustees, team leaders, assistant team leaders along with others serving in a leadership role, etc., are under the direction of and directly responsible to the Association* for the performance of duties as listed in his or her given area. No authority is granted to any individual or group to take any action or make any expenditure except as clearly indicated by Association action. Persons unable to attend scheduled meeting may be relieved and replaced. Replacement to be for unexpired term only. The associational year shall be September through August. **

(*) The word "Association" as used herein includes the Mission Board which is responsible for carrying on the business of the Association between the semi-annual meetings.

(**) See Robert's Rules of Order" for additional details.

GENERAL OFFICERS

The election of general officers shall be at the April meeting of the Association. They shall take office as the close of the October meeting and serve until the close of the next October meeting.

I. MODERATOR: The Moderator shall preside at all meetings of the Association and the Mission Board, abiding by the Constitution and designated rules of order so as to cause proper functioning of all business matters, always maintaining order and the best possible fellowship. He is ex-officio member of all organizations of the Association. He may resign his duty either temporarily, or permanently to the next officer under him that is present. The moderator shall not serve more than (2) successive terms.

II. VICE MODERATOR: In the absence of, or at the request of the Moderator, the Assistant Moderator shall assume the responsibilities of the Moderator. He shall serve as Chairman of the Executive Team.

III. CLERK: The Clerk shall:

1. Make and keep adequate and permanent records of all sessions of the semi-annual meetings of the Association. Prepare the same for print, seeing that they are printed and distributed to the churches.
2. Make and keep adequate typewritten records of all meetings of the Mission Board distributing a copy of each to the Associational Missionary, the Moderator, and the Assistant Moderator.
3. In the event of expected absence at any meeting he shall ask the Assistant Clerk to serve.
4. Be responsible for associational correspondence.
5. Prepare a digest of church letters for presentation at the October associational meeting.

- IV. ASSISTANT CLERK: The Assistant Clerk shall perform the duties of the Clerk when requested.
- V. TREASURER: The Treasurer shall:
1. Keep a permanent record of all money received for associational purposes, and of all expenditures, using associational recommended and/or approved forms.
 2. Prepare monthly typewritten reports to the Association and an annual report for the October associational meeting.
 3. Disburse funds only according to the budget, or upon action of the Association.
 4. Permit audit of Treasurer's books as desired by the Association.
 5. For financial accounting purposes, the associational year shall be January 1 through December 31. Cut-off date, for both monthly and annual reports, shall be the 25th day of the calendar month applying. Receipts and expenditures occurring after the 25th of the month will be shown on the next month's report.
- VI. ASSISTANT TREASURER: The Assistant Treasurer shall perform the duties of the Treasurer when requested.

ORGANIZATIONAL PERSONNEL

EXECUTIVE TEAM

There shall be an Executive Team. This team will function in an administrative role for our association. This team will be made up of the general officers of the association as well as the team leaders of all ministry teams. This team will meet quarterly to coordinate the following work and plans of the association:

1. Prepare the annual budget
2. Plan the annual & semi-annual meetings
3. Serve as what was formerly the credentials committee in handling requests of churches to join our association.
4. Nominate team leaders

TRUSTEES

The Association will have a total of (3) trustees. All future trustees shall be elected to serve from the end of the current annual meeting to the end of the next annual meeting. The trustees will serve by carrying out the following:

1. Supervise the care of associational owned property.
2. Review property at least once a calendar quarter, and recommend necessary repairs, changes, improvements, etc., so that the best use of the property may be had, and that its value may be maintained.
3. Sign legal documents as are expressly ordered by the Association.

WMU LEADERSHIP TEAM

The WMU Director and her Leadership Team will work closely with the Associational Missionary in the planning & calendaring of associational WMU activities. The director shall make a monthly report to the Mission Board.

YOUTH COUNCIL

The Youth Director and council will work closely with the Associational Missionary in the planning and calendaring of associational youth activities. The director shall make a monthly report to the Mission Board.

MUSIC

The Music Director and pianist will work closely with the Associational Missionary in the planning and calendaring of associational music events.

MINISTRY TEAMS

Team leaders, and assistant team leaders will be elected for each ministry team. The association may have as many teams as deemed necessary to carry out the work of the association. Each team will recruit their own team members. Team leaders will have a (3) year term limit, and assistant leaders will have a (4) year term limit. These leaders are to be elected for those terms at the Semi-Annual meeting following the election of General Officers. The nomination of team members will be presented by the Executive Team.



EQUIPPING TEAM (Equip Acts 2:42)

This team will assist, encourage, and resource churches to become healthy strong congregations as well as helping the leaders of each church to grow in their relationship with the Lord and to grow in their leadership skills for their area of ministry. This team serves churches by providing relevant resources, customized training and consulting that assist in developing the overall health and growth of churches (Examples: Sunday School, Vacation Bible School Clinics, Children and Youth ministries, etc.) This team will facilitate training, resources, support networks and professional development as well as emotional and spiritual health for pastors, staff, ministry leaders, their wives and families. They will work closely with the Executive team in planning and calendaring of activities. They should report each month to the Mission Board as well as prepare a printed annual report to be submitted at the October annual meeting.

EVANGELISM/MISSIONS TEAM (Evangelism Acts 4:12)

This team will assist, encourage, and resource churches to start new works that reach the lost and unchurched of our area as well as helping the churches of the Little River Baptist Association to be on mission with Christ through evangelism and mission opportunities. This team identifies and assists in starting and developing strategies to reach new people as well as the development of mission work locally, regionally, nationally, and globally. It works to coordinate partnerships, resources, personnel and training workers for church planting, missions, and evangelism. They should report each month to the Mission Board as well as prepare a printed annual report to be submitted at the October annual meeting.

ENCOURAGE AND EMPOWER TEAM (Empower Acts 1:14; Encourage Acts 14:21-22)

This team will encourage and empower our churches and leaders. The empowering is a focus on prayer because we know that apart from a move of God we have no power ourselves. This team will implement a plan to encourage not only our local churches and pastors, but also seek ways to encourage NAMB church planters as well as IMB missionaries. They will also develop a prayer focus and strategy for our association. They should report each month to the Mission Board as well as prepare a printed annual report to be submitted at the October annual meeting.

AUXILIARY TEAM MEMBERS

The Associational Trustees, WMU Director, Youth Director and Music Director are considered auxiliary members of the ministry teams. They should report each month to the Missions Board as well as prepare a printed annual report to be submitted at the October annual meeting.
